- 1. What is the Part 4 Professional Experience Recognition (PER) credit process?
 - The Professional Experience Recognition credit process requires a CIA candidate to meet certain requirements to be exempted from taking Part 4 of the 4-part CIA exam.
- 2. Is there a time frame in which I must complete and submit the PER documents?
 - You must complete and submit your PER documents and forms within prescribed time periods as indicated by the table that can be found at https://global.theiia.org/certification/cia-certification/Pages/Transition-Plan-for-CIA-Candidates.aspx.
- 3. Who is eligible for the Part 4 PER?
 - Candidates who have completed Part 3 but not Part 4 of the current 4-Part CIA exam.
 - Candidates must also hold an MBA or master's degree (5 to 6 years post secondary education) with a curriculum encompassing the 5 domains of Part 4 from an accredited university.

- 4. What are the requirements for the Part 4 PER?
 - A candidate will qualify for the Part 4 PER if:
 - The candidate holds an MBA or a master's degree (5 to 6 years post secondary education) with a curriculum encompassing the five domains of Part 4 from an accredited universtity;
 AND
 - The candidate must complete a detailed narrative of at least 75 to 100 words per domain describing examples of their experience within the domains of the current Part 4 exam. Experience in all five of the domains is required, and the candidate should document a minimum of 60 months experience.
 - The candidate must have successfully completed Part 3 of the four-part exam.
- 5. What are the 5 domains of Part 4 of the 4-Part CIA exam?
 - Strategic Management
 - Global Business Environments
 - Organizational Behavior
 - Management Skills
 - Negotiating
- 6. What is the Part 4 PER process?
 - The candidate must complete the CIA Part 4 Professional Experience Recognition Documentation and Verification form in its entirety, then must submit that form and any supporting documentation by the deadline to The IIA (through the Document Upload Portal) or the local institute as required.
 - Once submitted, the form(s) and documentation will be reviewed by IIA Global Headquarters to determine eligibility.
- 7. Am I required to complete at least a 100 word narrative for each domain that I have experience with?
 - Yes, you are required to complete a narrative for each of the 5 domains as indicated on the CIA Part 4 Professional Experience Recognition Documentation and Verification form. You must complete one form per employer.
- 8. How much does the Part 4 PER cost?

- 15. What happens if I do not complete and submit my Part 4 PER application before the close date?
 - Candidates who do not complete and submit their Part 4 PER application and documentation before the close date will not be eligible for the Part 4 PER and will not be granted their CIA under the 4 part format. In order to complete their CIA requirements, they must then sit for and pass Part 3 of the 3-Part exam.
